iPAD CONTRACT AGREEMENT 2011-12

This agreement pertaining to the use and care of an iPad is made and entered into as of August _____, 2011 between Delmarva Christian High School (DCHS) and:

As the parent/guardian of the above-named student who is enrolled at DCHS, I acknowledge that DCHS requires all students to have a DCHS issued iPad for school use. I am entering into this agreement on behalf of myself for the benefit of the student and I hereby assume responsibility for communicating the terms of this agreement to the student.

This device is for the purpose of conducting school work during school hours or while working on school-related projects; however, personal use of the device is permitted at other times, within the limitations of this contract, and within the Higher Standards Christ calls all His followers to. At all times while using the iPad, users will be held accountable for compliance with the DCHS computer related resources policy and the iPad policies and procedures.

DCHS reserves the right to take possession of the device at any time without prior notice, for any purpose it deems appropriate. To help find lost or stolen iPads, FindMyiPhone has been installed to map their location any time that a wi-fi connection is made.

SOFTWARE

I acknowledge that all apps installed on the iPad are the property of DCHS and that such are synced through a DCHS iTunes account. I understand that students are not permitted to install personal apps on the device nor are students permitted to remove any DCHS installed apps from the iPad.

HARDWARE

I understand that the iPad must be in an approved case at all times, unless removed for general cleaning. The iPad screen is to be kept free of scratches or other permanent damage; if damage occurs, an iPad Damage/Theft Report must be submitted to DCHS immediately.

SECURITY

I understand that DCHS has a secure wi-fi network on campus that is designed to prevent students from accessing inappropriate sites. I also acknowledge that DCHS has installed the Mobicip browser on all iPads to filter internet access from any wi-fi enabled area. DCHS has access to sites accessed using the Mobicip browser at all times.

INSURANCE

An optional insurance policy is available for the iPads. The insurance policy must be purchased within one week of the receipt of the iPad. Any damage which occurs before the insurance policy has been purchased is not covered by the policy. Any attempt to jailbreak (modify to run unauthorized software) the iPad will cancel this coverage; therefore iPads may not be jailbroken.

DCHS understands that an electronic device can be broken, and would not like to place the full burden of replacement on parents/guardians. In an effort to keep costs down, DCHS gives all parents/guardians the option to purchase insurance. The details of the insurance policy provide by DCHS are as follows:

Costs

Annual Premium: \$25

Deductible: 1st Incident: \$50, 2nd Incident: \$250, 3rd Incident: \$500

Coverage

The following items will be covered under the policy:

- accidental damage
- theft (must be reported to the police if off campus)
- fire, flood or natural disaster

Not Covered

The following items are not covered under the policy:

- loss
- intentional damage
- theft that occurs when iPad is not properly secured
 - left in unlocked car or home
 - left in unsecured bookbag

Claims

To file a claim both the parent/guardian and student must be present. The damaged iPad must be presented (or police report if theft has occurred). The parent and student will be required to complete a claim form and pay the deductible. Every effort will be made to immediately replace the iPad with the same model the student had. If the same model is not available the student may receive an older model iPad but will not receive a newer model.

_____ Parent/Guardian initial if optional iPad insurance is refused. Parent/Guardian understands that they are responsible to for the full cost (\$500) of the iPad in the event it is lost, stolen, or damaged.

_____ Parent/Guardian initial if purchasing optional iPad insurance. Parent/Guardian understands that the policy will not go into effect until payment is received.
